

**RESOLUTION 2021-3**

**A RESOLUTION OF THE  
READING PARKING AUTHORITY,  
COUNTY OF BERKS, PENNSYLVANIA**

Adopted: February 16, 2021

*TO LOWER PARKING METER RATES TO \$1.00 PER  
HOUR MAXIMUM FROM MARCH 1, 2021  
THROUGH AUGUST 31, 2021.*

WHEREAS, the Reading Parking Authority (“Authority”) is a body corporate and politic organized and existing under the Parking Authority Law, 53 P.S. §§ 5501 *et seq.* (“Act”); and

WHEREAS, City Ordinance 212-144 sets the maximum parking meter rate at \$2.00 per hour; and

WHEREAS, City Ordinance 576-508 states that City Council will establish maximum parking meter rates but authorizes the Authority to reduce the maximum parking meter rates established by City Council from time to time by a properly adopted resolution of the Authority; and

WHEREAS, the Authority does by this Resolution lower the maximum parking meter rates to \$1.00 per hour from March 1, 2021 through August 31, 2021; and


WHEREAS, parking mater rates shall return to \$2.00 per hour maximum on September 1, 2021, and continuing forward, unless otherwise modified by the Authority or City Council.

NOW, THEREFORE, BE IT RESOLVED, by the Board of this Authority, in lawful session duly assembled, that the Authority hereby adopts this Resolution to lower parking meter rates to \$1.00 per hour maximum from March 1, 2021 through August 31, 2021. Parking mater rates shall return to \$2.00 per hour maximum on September 1, 2021, and continuing forward, unless otherwise modified by the Authority or City Council.


