ENTER INTO A SALE AGREEMENT TO PURCHASE THAT  
CERTAIN REAL PROPERTY KNOWN AS: 1200 N. 10<sup>th</sup> STREET,  
READING, PA, PARCEL ID. NO. 17531737064883  
(HEREINAFTER, THE "PREMISES") AND TO EXECUTE ANY  
AND ALL DOCUMENTS NECESSARY TO CONVEY THE  
PREMISES TO THE AUTHORITY.*

WHEREAS, the Authority is a body corporate and politic organized and existing under the Parking Authority Law, approved June 5, 1947, P.L. 458, 53 Pa.C.S. §5501 *et seq.*, as amended and supplemented ("Act"); and

WHEREAS, the Authority wishes to and does by this Resolution authorize the purchase of the above described Premises from its current owner, Pennsylvania Conference Association of Seventh-day Adventists, Inc., for the total amount of Thirty Thousand Dollars (\$30,000.00).

NOW, THEREFORE, BE IT RESOLVED, by the Board of this Authority, in lawful session duly assembled, as follows:

SECTION 1. That Timothy J. Profit, Chairperson of the Authority is hereby authorized and directed to negotiate and execute a sale agreement with the respective owner of the Premises to purchase the Premises for the amount noted above.

SECTION 2. That Timothy J. Profit, Chairperson of the Authority is hereby authorized and directed to execute any and all documents necessary to complete the conveyance of the Premises from the owner thereof.
