RESOLUTION NO. 109-2022

**The Council of the City of Reading hereby resolves as follows:**

- Section 1:** Authorizing a temporary parking regulation Pilot Program for the installation of parking stalls at prescribed locations within the City and parking requirements related thereto, for a 90 day period, as more specifically stated as attached in Exhibit A, and pursuant to Chapter 576 Vehicles, Section 105 Experimental Regulations.
- Section 2:** On or about October 1, 2022 the Reading City Council shall determine if this temporary program is effective and if so shall enact an ordinance amending Chapter 576, Chapter 403 making this program permanent.
- Section 3:** This temporary parking regulation Pilot Program shall be effective July 1, 2022



## ATTACHMENT A

### Parking prohibited in specific areas.

Except when necessary to avoid conflict with other traffic or to protect the safety of any person or in compliance with law or the direction of a police officer or other traffic control device, no person shall:

Park outside the center of lines designating as a parking space. No portion of a vehicle shall be located on or over a line designating a parking space but shall be located within a single marked space. No vehicle shall be permitted to occupy more than one parking space at any time. All such regulations shall apply in the following areas:
